MINUTES OF THE COUNCIL MEETING HELD ON THURSDAY 15 MAY 2025

25/143 Election of Mayor

Current Mayor to open the meeting. Members to vote and elect Town Mayor. Elected Mayor to sign the Declaration of Acceptance and take the Mayor's position.

Councillor Webster was proposed by Cllr Akker and seconded Cllr Hinderwell. Councillor Powling was proposed by Councillor Boylan and seconded by Councillor Jenkins. After a vote, the Council RESOLVED by majority to elect Councillor Webster as Mayor.

25/144 Election of Deputy Mayor

To elect a Deputy Mayor. Deputy Mayor to sign the Declaration of Acceptance.

Councillor Hinderwell was proposed by Cllr Akker and seconded by Cllr Webster. Councillor Jenkins was proposed by Cllr Powling and seconded by Cllr Boylan. After a vote, the Council RESOLVED to elect Councillor Jenkins as Deputy Mayor.

25/145 To receive apologies for absence and a vote of acceptance to be taken.

None received.

25/146 Declarations of Interest

Cllr Powling declared his interest as a Colchester City Councillor.

25/147 Public Participation:

MOP1- Requested that the Town Council register Broomhills Greensward as a Village Green and a Public

Right of Way. Raised the problem with purchasing a season ticket for the sea front car park.

MOP2- Stated that the alexander weed on Glebe 1 and 2 is spreading and needs cutting and that rubbish is piling up behind Glebe recreational shed. Mentioned his concerns about discharge of sewage.

MOP3- Expressed his thanks that the hedge and the grass had been cut at the bottom of Fairhaven.

MOP4 – Noted his concerns that some green areas were cut during no cut month of May.

MOP5- Expressed his thanks for the Town Council for providing a decent timetable for the new bus service from Mersea to Colchester.

25/148 To receive County and City Councillors reports.

Cllr John Jowers gave an update on the following:

- Talked about Government reform and County Elections.
- Colchester City Council may lose their city status and be parished.
- Recommended staying with the EALC.
- Questioned who will be responsible for the spends on adult social care and SEND.
- Mayor of Essex will be an important post, and other jobs may be lost in the process.
- Believes the future lies with parishes who should look at coordinating their time and working together.

Cllr John Davidson gave an update on the following:

- The biggest hurdle at the moment is financial stability – two thirds of the County Council budget is allocated to Social Care. Colchester and Tendring are the biggest applicants for the money, but will they get their fair share needed to deliver the services.
- Noted that there will be a labour mayor, council and government.
- Colchester is responsible for weekly tests on the sea water, and it is important that we monitor this.

Cllr Parsons gave an update on the following:

- Mersea has been allocated 300 houses.
- Water report was not in place before houses were put in place in Langham.
- Mentioned the fact that the GP problem was ignored in the Local Plan.
- Raised concerns about the local plan- if it's not completed in time, it could leave us open to speculative development. The other risk is the planning inspector turning down the local plan.

Cllr Powling gave an update on the following:

- Stated that the Mayor of Essex won't have the same full power as a Metropolitan Mayor.

25/149 To confirm minutes of the Council meeting of 10th April 2025

25/150 To receive the Town Clerk's report

- The Action Plan has been updated and is ready to be published on the website.
