25/29 To appoint a Chair for this meeting

It was *resolved by majority* to vote Cllr Akker as the Chair.

25/30 To receive apologies for absence and a vote of acceptance to be taken

Apologies were received from Cllr Webster and Cllr Williams. All in favour.

25/31 To record declarations of interests

25/33 To confirm minutes of the Community Assets & Facilities Meeting of 4th June 2025

25/34 To consider and agree if a CCTV survey of the drainage system at the Glebe is required to ascertain the reason for blockages

Following discussion, it was agreed that the Town Clerk would source quotes for a CCTV survey of the drainage system at the Glebe and bring back to full Council or the Community Assets/Facilities Committee meeting (whichever comes first) for their consideration.

25/35 To review and agree next steps with regards to three failed drain covers at the Glebe

It was noted that the Chair of the Committee and the Town Clerk, acting under the delegated spending powers of less than £1000 on emergency repairs, have already undertaken to pay the repair cost of £992.00 for the three failed drain covers at the Glebe.

25/36 Coast Road path – To consider and agree next steps

Following discussion, it was agreed that the Town Clerk would:

- Contact the planning Manager at Colchester City Council and ask his opinion on whether laying a hard surface (tarmac /concrete) would need planning permission and whether the pathway being in a conservation area would need to be considered.
- Talk to the landowners to ask for their agreement that 1500mm starts from the fence line.

25/37 To agree a quote for works to the isolation switches on the 11 Wallgate systems at a cost of £390 + VAT

It was *resolved unanimously* to agree to pay the quote for the isolation switches on the 11 Wallgate systems at a cost of £390 + VAT.
